



## PLATINUM LEVEL MEMBERSHIP

### Platinum Level Plan includes:

- \$85 rental fee, per locker, per month with choice of six-month or one-year term.
- Access to Club 55 online inventory management system.
- Online arrangements for wine transfers and/or personal pick-up services.
- Processing/handling services for wine delivered, shipped or received on your behalf.
- Pick-up services in Napa and Sonoma Counties.
- Up to two authorized owners allowed per account.

### Terms of Agreement:

- 55° requires a valid credit card, photo ID, signature, residential and email address on file for membership. It is the member's responsibility to inform 55° of any changes to this information.
- Renews automatically upon expiration of 6-month or 1-year term unless member notifies 55° of cancellation by the tenth (10<sup>th</sup>) day of the term's end month.
- Online Transfer and Personal Pick-Up Requests are processed on a first-come, first-served basis and require up to 48-hour advance notice. Orders requested less than 48-hours in advance may be subject to an expedite fee.
- Personal Pick-Ups are allowed during normal business hours of 8:00 a.m. to 5:00 p.m. Monday through Friday and Saturday by appointment.
- Any wine delivered to 55° on behalf of member, must be properly packaged for storage and handling and clearly marked with the member's name as it appears on the membership agreement.
- Locker capacity is 10-12 standard cases. If wine is received exceeding the locker's capacity, 55° reserves the right to automatically add another locker to the membership agreement.
- Renewal rates are subject to change without notice upon expiration of existing term.

*This is a Self-Service Rental Agreement under the provisions of the California Self-Storage Facility (California Business and Professions Code Section 21700 and following). This rental space is a temperature controlled environment for the sole purpose of storing wine.*

**Lien:**

1. Any account overdue by 30 or more days will be locked by 55° and the contents of locker(s) will not be made available until the account is paid in full.
2. If an account remains overdue for sixty (60) days after member has been notified, 55° has the right to sell locker contents. The proceeds of such sale shall be first applied to any indebtedness owing to 55° and to any costs and expenses incurred with respect to the goods, the sale, and any efforts to collect such indebtedness. Any excess shall be remitted to the member (Lessee).
3. The enforcement of the lien is authorized by the provisions of the California Self-Storage Facility Act which is found at Chapter 10 of Division 8 of the Business and Professions Code of the State of California (Section 21700 and following or under any other provision of law).

**Liability:**

1. 55° (Lessor) assumes no liability whatsoever, regardless of the member’s (Lessee’s) level of membership plan, for any loss or damage, regardless of the cause thereof to the goods stored. Goods are stored at the Lessee’s sole risk of loss or damage from any and all causes, including damage due to Lessor’s handling of Lessee’s wine, and according to the California Self-Storage Facility Act.
2. Lessee shall maintain insurance covering any loss or damage to Lessee’s wine. Upon request, Lessor will refer broker name(s) claiming to be knowledgeable in providing insurance for wine.
3. Lessor will be held harmless in the event of any natural disaster.
4. Lessor shall not be held responsible for loss or damage due to deterioration of the wine for any cause.
