



## PLATINUM WINE STORAGE AGREEMENT

**This Wine Storage Services Agreement (“Agreement”) is made between 55 Degrees LLC, a California limited liability company (“55”), and the client identified on the signature page to this Agreement (“Client”):**

### **Platinum Level Plan includes:**

- \$90 rental fee, per locker, per month with choice of six-month or one-year term.
- Access to Club 55 online inventory management system.
- Online arrangements for Wine transfers and/or personal pick-up services.
- Processing/handling services for Wine delivered, shipped or received on your behalf.
- Pick-up services in Napa and Sonoma Counties.
- Up to two authorized owners allowed per account.

55° will provide temperature-controlled warehousing, storage, handling, and related services for wine tendered by Client from time to time (“Wine”) under this Agreement. 55° shall provide these services at its warehouse facility located at 1210 Church Street, St. Helena, CA 94574 or at its nearby facility located at 1078 Fulton Lane, St. Helena, CA 94574.

### **Terms of Agreement:**

- 55° requires a valid credit card, photo ID, signature, residential and email address on file. It is the Client’s responsibility to inform 55° of any changes to this information.
- Renews automatically upon expiration of 6-month or 1-year term unless Client notifies 55° of cancellation by the tenth (10<sup>th</sup>) day of the term’s end month.
- Online Transfer and Personal Pick-Up Requests are processed on a first-come, first-served basis and require up to 48-hour advance notice.
- Personal Pick-Ups are allowed during normal business hours of 8:00 a.m. to 5:00 p.m. Monday through Friday and Saturday by appointment.
- Any Wine delivered to 55° on behalf of Client, must be properly packaged for storage and handling and clearly marked with the Client’s name as it appears on the Agreement.
- Locker capacity is approximately 10 standard cases. If Wine is received exceeding the locker’s capacity, 55° reserves the right to automatically add another locker to the Agreement.
- Renewal rates are subject to change without notice upon expiration of existing term.

**Lien:**

1. Any account overdue by 30 or more days will be locked by 55° and the contents of locker(s) will not be made available until the account is paid in full.
2. If an account remains overdue for sixty (60) days after Client has been notified, 55° has the right to sell locker contents. The proceeds of such sale shall be first applied to any indebtedness owing to 55° and to any costs and expenses incurred with respect to the goods, the sale, and any efforts to collect such indebtedness. Any excess shall be remitted to the Client.

**Liability:**

1. Risk of Loss; Client to Insure. As a material consideration to this Agreement, Client and 55° agree that Client shall insure all of Client's Wine for all risk of loss from any cause whatsoever. **Client shall obtain its own insurance policy through its own insurance agent or carrier for all Wine subject to this Agreement.** The Wine will not be insured by 55° for the benefit of Client against any risk whatsoever including fire, theft, loss or any other casualty
2. 55° will be held harmless in the event of any natural disaster.
3. 55° shall not be held responsible for loss or damage due to deterioration of the Wine for any cause.
